

Risk Compensation

Risk Aversion | *Hypothesis*



"Patients regularly don't follow physicians orders for taking their medication because they don't see this as a truly risky behavior...



Therefore, when costs become a major challenge, they are not averse to modifying their medication behavior because they don't see it as being risky."



Ranking of Risky Behaviors

Respondents were asked to rank the following list of "risky behaviors" from '1' to '9' with '1' being the riskiest behavior

Pre-List of Risky Behaviors

Biking without a helmet	Driving while intoxicated (DWI)
Eating expired foods	Experimenting with illegal drugs
Not wearing a seat belt while in a car	Not taking prescription medication as instructed by your doctor
Smoking Cigarettes	Unprotected sex with strangers
Sky Diving	

Perception of Risky Behaviors


Patients perceive 'not taking prescription medications as instructed by your doctor' as slightly less risky than 'smoking cigarettes' along the spectrum of risky behaviors.

Mean Summary

(1=riskiest, 9=least risky):



- 3.67 Experimenting with Illegal Drugs
- 4.22 Having unprotected sex with a stranger
- 4.34 Smoking cigarettes
- 4.83 Not taking prescription medication as instructed
- 5.54 Not wearing a seat belt
- 5.87 Skydiving
- 6.29 Biking without a helmet
- 6.93 Eating expired foods













Rising Oncology Medication Costs

Impact of Rising Costs of Oncology Treatment | *Hypothesis*



"Financial toxicity associated with increasing costs of medication and treatment are impacting patient outcomes. As patients make tradeoffs to both lifestyle and care, oftentimes the result is less compliant behavior to recommended treatment plans."








Reaction to Diagnosis | Concerns are High for Both Costs and Care

Half of all patients indicated being extremely concerned for their cost of treatment, quality of life, survival rate, and cost of medication.



"What treatment, would insurance cover it, and quality of life during and afterwards"

Impact of Rising Medication Costs

In total, **62% believe cost of medication is unmanageable** or ridiculous and needs to be addressed/controlled. Those under 35 estimate a significantly higher percentage of their costs go to paying for just their medications.

Age: 65+











Impact of Rising Treatment Costs | Hardships and Lifestyle Changes for Many


Most patients indicate the cost of cancer medication has or will effect at least one aspect of their lifestyle, with 34% experiencing <u>significant</u> changes to their lifestyle.

Lifestyle Adjustments | *Medication Costs are Forcing changes*

Medication costs have forced lifestyle changes. Among those claiming changes to lifestyle, one in four patients either have or anticipate cutting back on family necessities.





"My family has had to go without things that I feel like they need and should have so that I can afford my medications and treatment."

Out of Pocket Consideration | Weighing the Impact

Eighty percent of patients consider the cost of medication and weigh the financial impact.




"Sometimes I can't afford [Medication] so I need to take a cheaper option"

"Because I do not wish to put too much financial burden on our family."

"I hope to survive and not be in huge debt after"

Consider Costs Do Not Consider Costs



"I have good coverage & low copays"

"My insurance covers the cost."

"Cost is not important when it comes to my health"

"I do not have a choice. Without my medication, my cancer would grow."



Agreement with Statements | Costs and Compliant Behaviors

Two-thirds of patients believe Healthcare costs too much, and close to half either strongly agree or are neutral with the statement "it's no big deal to occasionally miss a dose."

"I worry about sacrificing my family's financial position for my health."





Rising Oncology Medication Costs and the Impact on Patients

Nearly half of patients make changes to their treatment regimens in order to help manage costs. Patients 34 years or younger are more likely than older groups to exhibit non-compliant behavior in order to manage costs.

Wrapping Up

Costs are high and drive behavior change



For oncology patients, cost has become a major concern and has forced >50% of patients to make changes that impact their lives and the lives of their families in order to treat their disease.

Non-compliance not perceived as terribly risky



Skipping or reducing medications is not perceived as terribly risky and patients are willing to take that risk.

Even oncology patients, across all stages of disease, do not believe that non-compliance is all that risky and are prepared to modify their treatment regimens in order to address the burden of cost.
